

# **'TRAVEL WITH CAMBRIDGE' PRIZE DRAW**

## A. TERMS AND CONDITIONS FOR PREPARATION CENTRES

## I. ORGANIZER OF THE PRIZE DRAW

This prize draw is organized by Fundación UCLES, holder of Tax ID (NIF) number G8I993792, with its registered office at C/ José Abascal 56, I° - 28003 Madrid (Spain), recorded at the Foundations Register under number 4I2EDU (hereinafter 'Cambridge' or the 'Organizer').

## 4.1. Publication of the launch of the prize draw

On I January 2024 the Organizer shall publish the terms and conditions of the prize draw on the travelwithcambridge.org website in PDF format, where they will remain available until 3I July 2024, and there will be a link to the said terms and conditions on the registration form for the prize draw.
